

A frequent visitor to South Florida and guests of Charlie and Nancy Seraydar, we often visited. And of course, we always talk on the phone. Buck begins every con-

versation with a joke. He called one day and told me, "I think my wife is dead." My heart immediately skipped a beat, because his tone was alarmingly serious. I responded- "Why Buck?". His reply to me was "Well the sex is the same but the dirty dishes are piling up!" What a relief! The conversations continue, where more jokes are followed with an update on our families, discussion over current events and then Buck, my personal "Paul Harvey", shares some of his historical knowledge. Still training the new kid!



I sometimes get letters from Buck and cards and notes from Fran; and I treasure them. Most people don't know that Buck loves to write poetry; and that the subject of his poems more often than not is Fran, the love of his life.

Now I pause to start another story which will cross paths with this one.

My son Jason (without my consent, as he wouldn't have gotten it), joined the Army over 2 years ago. Just as he was graduating Airborne school, and I realized he would be Afghanistan bound, my husband Lenny's oldest and dearest friends came for a visit from France. I wanted to attend Jason's Airborne graduation and do something special for our friends at the same time. Since they love country music, which is very popular in France, I planned a trip to Nashville, and on the way home, the graduation at Fort Benning.

While in Nashville, we went to the famous Bluebird Cafe. Owned by the Songwriters Guild, the Bluebird is a starting place for nearly everyone in all

music genres. Performers must sing and play only original music. It is considered an honor to even be invited to perform there. This night, a young singer and songwriter named Mare

Wakefield was performing. Mare (pronounced 'Mary') sang a song she had just written called "About the War". I will not lie, I started crying from the first line which was "I had another bad dream again about the war". The entire song expressed everything in my soul.

After the show, I spoke to Mare and her husband Nomad. I explained to them that I *had* to have that song. I knew many military moms who needed it. Mare explained she had not yet recorded it but



I was insistent and emotional. She suggested I give her my e-mail address which I did, writing it on a napkin. She told me she'd do a demo of the song and e-mail it to me. I thought to myself, "yeah, right, I'll never hear from her".

When I arrived home a few days later, I was shocked and delighted to find the song I wanted waiting for me. It was a rough copy, but Mare's beautiful voice and her guitar came through beautifully. The song has since been a winner in the Great American Songwriting contest; and just last week, Mare included it on her newly released CD. So began a new friendship with Mare and Nomad as we emailed while she toured and wrote new songs. Last June, Mare and Nomad came to visit and I planned a "private" concert in my home. Of course I asked many of my police friends to come. First on my list of course, were Fran and Buck. Buck loved the story of how I met Mare and the song that drew me to her, so he agreed to come as he said "one last time".

Buck told me he wanted to visit some graves, some places and some friends during his visit. I had the privilege of chauffeuring him to some of his meetings with old friends. First was breakfast with Jack Tighe. I always love to see Jack. Although he finds it difficult to speak these days, he is always understood, perhaps because he is conversing with old friends who know him so well. Either way, Jack is a beautiful person and Amy and he are yet another great love story. Next was Lou Reilly, whom we met for lunch. Lou still has his movie star good looks; and the first thing Fran asked me afterwards was if he was still gorgeous! A classy, decent man and a great boss. Last was Jim Kelly. Jim still owns Kelly's Bar, for more than 2 decades in downtown Hollywood, but is usually there only in the early morning. What a character! I wish I could share with all what they spoke about, but after some consideration, I decided to keep private what was said in what may be final meetings between old friends and co-workers.

I will always remain grateful to them for allowing me to be a part of it, and I'll also say that what I witnessed is what this organization is really all about. Buck did not get to see all the dear friends he wanted to, there simply wasn't enough time as he and Fran needed to get home. Besides, for the first time, I was keeping pace with him!

And then there was the concert. Mare and Nomad fell in love with all my police friends and they them. Though she began a European tour the following week, she and Nomad e-mailed often to say they were telling everyone about the Beach cops they had met. At the concert, they spent time with everyone, but Mare was struck by the love she observed between Buck and Fran. With Buck's permission, Mare took some of his poems with her. After her European

thing in his note and in the phone call made me stop and take measure of how much his and Fran's friendship has meant through the years. It's winter time now and it seems the appropriate season to reflect on some of the people who are important in our lives. I just did. And thanks again to Buck who showed me that the road to a friend's house is never long. So like he did, make that drive or call, send that letter or e-mail, let a career long friend know you are thinking about them.

"I just got my hot little hands on 14 pages of stuff about who last year made Officer of the Month, Medals of Valor, Outstanding Service Awards, civilians given awards, and Officer of the Year".

OFFICERS OF THE MONTH FOR 2010

January- Officer Leon Azicri (One of retiree Sammy's sons): While off duty on West Avenue, caught up with and arrested a thug wanted for armed threats, even finding a bb gun in the car.

A suicide note was already written and was found inside. Our cops spoke to her and distracted her to the point where Fugi (my friend) was able to grab her and bring her back to life. I am beyond proud of all of them! Turns out they gave her new medication which did not agree with her.

OUTSTANDING SERVICE AWARD

Many of you probably know Sgt. Jeff Cohen, who is the Motor Supervisor. Well, last year he was doing a Super Bowl escort when a Maserati pulled out in front of him at 13th and West. He crashed and got hurt with some bad road rash. While in the Rescue truck, he pulled out his radio and continued coordinating the escort for 20 buses to the Sunlight Stadium. He got treated and released and went back to work within an hour and a half of his accident. I say he's crazy, but my real opinion, he's why I'm glad I worked for MBPD. True crazy heroes, if you ask me!

MEDAL OF VALOR

Officer Duane Rezende: Officer Rezende, with the Marine Patrol risked his life during a tropical storm to help save a diver in distress. He, along with the US Coast Guard and MB-Fire Rescue ventured out in 6-8 foot (and sometimes reaching 11-13 ft) waves, winds at 28-33 knots with gust reaching 45 knots approximately 6.2 miles from shore. He was operating one of MBPD's 25ft open fishermen boats. The diver was found alive! Score one for MBPD's Marine Patrol! By the way, the equipment he was in was far inferior to what everyone else had; yet, our guy persevered!

Officer Jose Reina: The weird thing is that I was there when this happened. A thug took a taxi from 36th and Biscayne to 17th and Alton. When they got there, the "passenger" tried to rob the cabbie. After a struggle, the thug fled the cab, but came back, putting a gun to the cabbie's head. The cabbie got pistol whipped and drove to 17th and Meridian. Crime Suppression Detectives Jose Reina and Mishart Torres got there and found a guy fitting the description walking at Lincoln and Jefferson. He ran. During the chase, they saw him turn and saw what looked like a gun in his hand. They "unloaded" on him. The bad guy caught a bullet at Lincoln Lane south and went down. I arrived to hear gunshots echoing throughout the whole area. I got the guy hiding under a car and held his head down with my foot until rescue

got there. Man, it was crazy! Jose, you did a great job, my hat's off to you buddy!

Finally. the Tighes, die hard Hurricane fans. As we left our party we found the U had the rooms next to ours and as we waited for the eleva-


tor, Sebastien the Ibis, U Miami's mascot was coming out. Tighe family greeted him with a C A N E S

Odds n Ends

The following was written by Chief Carlos Noriega and was placed in the MBPD's Official Bulletin.

INCREASED ASSAULTS ON LAW ENFORCEMENT

The two MDPD Officers killed in the line of duty last Thursday and the two St. Petersburg Officers killed in the line of duty on Monday, serve as tragic reminders about the perils inherent with our profession. In addition to those two horrific incidents, there has been a disturbing trend of increased assaults on law enforcement personnel across the country. In a story dubbed "War on Cops" released a couple of days ago by Police Magazine, it was documented that eleven officers around the nation were shot in a 24 hour period. This story and other recent similar stories have implied that law enforcement personnel are becoming "targets". Yet, in spite of what we as public safety professionals risk each day, local publications like the New Times continue to maintain an antagonistic position against Law Enforcement. I want to take this opportunity to remind all of our personnel that Officer Safety is our primary objective, prior to anything else we do to serve our community. Initiatives to include an Officer Safety Committee, an Assault Rifle Program, a mass casualty "Operation Cassandra" exercise, an upcoming department wide transition to a new and improved firearm, the purchase of an automated "FATS" simulator to expose our officers to a variety of real life shooting scenarios, and improved/enhanced training (to include ground fighting tactics) are all initiatives implemented under this administration. We will continue to look at anything and everything we can do to ensure that Officer Safety is maximized for our personnel.

Please think safety first as you conduct your duties and responsibilities in the most professional manner possible.


