It also shows Chief Rocky Pomerance at his best. The original task force worked in civies driving unmarked vehicles. One night while most of the units were driving the north end, one ran into such a fight at the drive in on the west side of Normandy Isle. Being so close the task force units were the first on scene. In attempting to stop the fight, we ended fighting some of the participants, then arresting them. An elderly couple followed to the station then demanded they speak to the Chief about police brutality. Rocky had the couple in his office listening about one of our officers beating a person to the ground then kicking him. While making the complaint, a young man passed the doorway.

Immediately, the woman yelled that the person was one of those who kicked and beaten by police. Rocky had them write a summary of what had occurred. After they wrote their stories, Rocky had the youngster the couple were

complaining about return to his office where he identified the "victim" as Officer Pete CORSO. Then he thanked the couple telling them they would be called as witnesses against the persons arrested; the elderly couple were never heard from again.




2009 FOP installation dinner and banquet

John Walsh then began and still hosts America's Most Wanted. The case was closed the end of 2008 when the Hollywood Police Department officially named Ottis Toole as Adam's killer. John Walsh was not present for the award but it was accepted by Joe Matthews. In a letter from John Walsh he thanked the FOP and especially thanked Joe for his assistance in the Adam Walsh investigation stating that without his help Ottis Toole would not have been named Adam's killer nor would the case had been closed by the Hollywood Police Department.

The FOP member of the year was Robert Silvagni. Rob has been on the executive board for many years along with numerous FOP committees.

The Officer of the Year Award was presented to Officer Anthony Ferbeyre who was involved in numerous arrests including an Armed Robbery and help saving people from an apartment fire.

He never was promoted but worked patrol, then the desk toward the end of his police career. He moved to California after his retirement and every so often would send me a note about something I had written

I think it was five years ago that thee organization began a policy of sending holiday checks of a \$100 to six widow who were receiving a less than six hundred dollars a month. Three years ago the FOP matched our donation. Then we added four more widows, getting less than \$1,000 a month, with the FOP again matching our donation. Through this donation we, and the pension board, learned Mrs. George GORHAM had passed away two months ago. Her husband George GORHAM was an ID Officer who served from 1942 to 1970.

Meet the retirees...Officer Greg Strong

Greg Strong's name was and is synonymous with one thing: Traffic enforcement! As a motorman on the Police Department, he struck fear in the hearts of many motorists (and some cops). When Greg stepped out in the street, he usually had a portable laser unit in one hand and a ticket book in the other. The numbers on the blinking laser unit display most certainly signaled doom for most motorists. If Greg stopped someone, 97% of the time, they were getting a ticket. And rightfully so, Miami Beach has some of the worst drivers in the entire country. Greg's retirement has definitely left a huge void in terms of traffic enforcement on the Beach.



In addition, Greg's vast, textbook knowledge of the traffic laws and other various traffic related issues had been invaluable to his co-workers. I recall being in court one day, testifying on a speeding case. The guy I cited had driven his sports car through a school zone at about fifty miles per hour. He (like many motorists we encounter these days) was a real jerk, and I wanted to get him good! Unfortunately, I used the wrong statute number on the ticket and was on the verge of losing the case. Greg stood up and saved the day for me. Acting almost as MY attorney, he quoted me the correct statute number from memory, instructed me to amend the citation, and then got the magistrate to go along with it! He was extremely well respected in court and his word was good as gold. The jerk shuffled away with a five hundred dollar fine. I can think of many other examples where Greg went out of his way to make life easier for his co-workers. Another good example is the "pocket sized" traffic statute guide he created for the entire Department. We needed one that was easy to use and contained the most commonly used traffic violations, and Greg came through for us!

Gregory Strong was born in Cincinnati, Ohio in July of 1952. Until the age of ten, he lived in the North College Hill section of Cincinnati, and then moved to Miami in 1962. Greg attended Southwest Miami Senior High where he played junior varsity football and varsity basketball. Greg later went on to join the United States Army and was assigned to the 5th Special Forces Group at Fort Bragg, North Carolina from 1973 until 1976.

In 1977, Greg graduated from Florida International University with a BS in Criminal Justice. Some of his jobs during and after college included the following: Investigative clerk for the Miami Division of the FBI, and ditch digger for a sprinkler


